1. In pursuance to the last order, Action Taken Reports (ATRs”) have been filed by the Respondent Nos.1, 3, 4 and 5.

Accordingly, the learned Court Commissioner, in accordance with order dated 1<sup>st</sup> November, 2023, is directed to carry out a fresh joint inspection and file a fresh report before this Court within five weeks. Learned Court Commissioner is directed to video-graph the entire proceedings and file the same. The costs shall be borne by the Animal Husbandry Unit, Development Department, Government of NCT of Delhi.
3. It is directed that the petitioners as well as respondents shall cooperate with the Court Commissioner and the Court Commissioner shall give prior notice of the date of inspection to the parties.
4. The respondents are also directed to depute their representatives to accompany the Court Commissioner for inspection. The local Police shall provide all necessary assistance to the Court Commissioner.
5. Needless to mention that in case any violation is noticed at the time of inspection by the teams led by the Court Commissioner, the parties will take appropriate action in accordance with law.
