Subject: Security Notice: Heera Group's Official YouTube Channel Compromised

This is to inform all our members and the general public that the official YouTube channel of Heera Group has been illegally hacked and taken over by **Mohammed Akheel** Alias **Adil** S/o Mohammed Bahaddur, aged 32 years and **Mohammed Muneeb Khan** Alias **Abdullah** S/o Shafiulla Khan Aged 31 years, **from 1-Help Technology and Software Solutions Pvt Ltd.**, who were earlier engaged as IT service providers for the company. These individuals have committed a severe breach of contract and a criminal cyber offense by unlawfully accessing and seizing control of our digital property.

They are now misusing the platform and have even issued threats to the company, with malicious intentions to harm the reputation and trust of Heera Group. Their actions fall under serious cybercrimes, including hacking, identity theft, cyberstalking, and misuse of digital platforms, as outlined under Indian cybercrime laws.

We are actively working with legal authorities and cybersecurity experts to take action against the offenders and to recover our YouTube channel.






